Tabernacle School Statement of Faith

_____ 1. I believe the Bible to be the Divinely inspired and infallible Word of God II Timothy 3:16). I accept the Bible as the supreme and final authority in all matters pertaining to faith in all matters pertaining to faith in Christ and life. (II Peter 1:21).

_____ 2. I believe there is one God (Deut. 6:4), eternally existing in three persons: Father, Son, and Holy Spirit. (Matthew 28:19). God the Father, Creator, and Ruler of the universe, from whom all life exists through His Son (Colossians 1:16; Genesis 1:1); Jesus Christ, God the son, who became the God-Man to fulfill the eternal plan of God for the redemption of mankind (Philippians 2:5-11); God the Holy Spirit, revealing Jesus Christ and God's plan to mankind and bearing witness to God's work in our world (John 1:1-3, 16;7-14).

_____ 3.
